1 Minutes of last meeting

2 Matters arising

Communion

under both kinds: Leonie had contacted the SMs. There are enough people willing to

distribute and/or purify the chalice for Communion under both kinds to resume at the 6pm and 9am Masses, but not enough for the 11am Mass. She has put together a rota which could start on 23 November. It was agreed that

this should go ahead. Colin would inform Leonie and Fr Peter would prepare the congregation by speaking about the subject at the coming

weekend Masses and putting an item in the newsletter.

3 Updates

The Social Club Committee has a fixed number of members but it needs more people to help. It was proposed that a Planning Group be set up to work with the committee. Simon and Sarah will put together a document with the terms of reference for the new group and contact details for

Elderly Craig had bought Christmas cards. There were three people currently in

need of a lift to church for Saturday/Sunday Mass. It was suggested that an appeal for volunteers be made at the Saturday/Sunday Masses, with the 6pm Mass being the priority. Erica will write an item to go in the newsletter and in the Mailchimp email; Gerry will make an appeal at the end of the 6pm Mass this coming Saturday and will be available after Mass in case any

Listening group Attendance is still low. Sara Waite will be discussing the future of the group

with Fr Peter. The group attended a Service for Remembering in Old

Coulsdon on 3 November; this was moving and sensitive.

Welcome The first edition of the Welcome booklet had been distributed at Sunday

Masses and via Mailchimp and is available on the website. Copies are available at the back of the church and welcomers give them out to new parishioners. Colin has produced an updated version as the welcomers were

not included in the list of parish activities in the first edition.

Colin has put a page about the history of St Aidan's Church on the parish

website.

Laity & Faith Parish Plan: The group has found that because there were only three people

4 Synod on Synodality

The bishops had met in the Vatican for the Second Session in October, and the final report had been issued on 26 October and approved immediately by Pope Francis, which means that it can be implemented immediately. Richard outlined the main points of the report; his summary is appended at the end of these minutes. The final report is available on the <u>Vatican website</u>. Richard will distribute the report to the PPC members, who are asked to read it. At the next meeting we will discuss whether there are things we can do in the parish now to implement any aspects of the report. [Action: Richard, ALL]

5 Any other business

Car Park: It was generally agreed that the new arrangements for using the car park

were working well. There had been some comment on social media from a person who had been fined for using the car park, but responses from local

people had defended the parish's approach.

Bar keys: There needs to be some way for the bar staff to get access to the bar keys

during the 11am Mass, but the safe cannot be left unlocked. Simon would

speak to the sacristan to arrange for the keys to be made available.

Appendix: Synod on Synodality's Final Document: Key Takeaways

- Pope Francis approved the final document of the Synod on Synodality, marking a shift from past synods by directly implementing its conclusions instead of issuing a separate apostolic exhortation.
- The document is the result of a two-year consultative process involving global input, leading to 1,135 amendments.
- Key proposals include expanding women's leadership roles, increasing lay participation in decision-making, and implementing significant structural reforms.

Structural Reforms

- Strengthening pastoral councils at parish and diocesan levels.
- Regular ecclesiastical assemblies at all Church levels, including continental gatherings.
- Increased ecumenical dialogue.

- Introduction of "synodal authority" while maintaining the authority of the Bishop, Episcopal College, and the Bishop of Rome.
- Revision of canon law to clarify the roles of consultation and deliberation in decisionmaking.

Women's Leadership

- Explicitly states there is "no reason or impediment" to prevent women from assuming leadership roles.
- Keeps the question of women's access to diaconal ministry open for continued discernment
- Advocates for increased female participation in clergy formation and Church decisionmaking.

Lay Participation

- Expands the role of lay faithful in Church governance.
- Calls for increased lay presence in synodal assemblies and all phases of ecclesiastical decision-making.
- Proposes new procedures for selecting and evaluating bishops and expanded lay participation in diocesan leadership and canonical processes.

Implementation Phase

- Emphasizes the crucial implementation phase ahead, focusing on integrating synodality as a "constitutive dimension of the Church."
- Addresses accountability measures, including enhanced financial transparency and abuse prevention protocols.

Background

- The document represents the culmination of an extensive consultative process in Church history.
- Aims to balance traditional Church teaching with contemporary pastoral needs while promoting greater inclusivity and transparency in Church governance.

Key points from comments:

- Concern that "synodality" may become a primary focus, potentially overshadowing traditional aspects of the Church.
- Questions about how the proposed changes will be implemented and how they will impact the Church's relationship with other Christian denominations.
- Calls for clarity and caution in navigating the proposed reforms.
